

## Contract of Photography Services

### *Rogue Valley Resolution*

**Description of Services:** Rogue Valley Resolution prices its photography services at an \$89.99 hourly rate. The number of photos taken will have no effect on the pricing or inherent value of the hour session. After the session/ sessions the client will have all the photo/ photos that were taken by the photographer during the session/ sessions sent to their phone number within one full week, the countdown starting the date after the photographer has received payment in full for the session/ sessions (session/ sessions assumes all sessions occurred on the same date) from the client. Upon receiving the photo/ photos, the client will be given the option to select up to five photos from their last session/ sessions with the photographer to be edited free of charge. The client will then send their selected photo/ photos to our phone number via text message. The client will receive selected free edited photo/ photos within two weeks, the countdown starting the date after the selected photo/ photos are received by the photographer from the client via text. The extent to which the selected photo/ photos are edited/ altered is solely determined by the photographer.

Additional edited photos will cost \$9.99 per edited photo. These photos do not have to be photos taken by the photographer from the last or any previous sessions. The client will upload the selected photo/ photos on our website ( [www.roguevalleyresolution.com](http://www.roguevalleyresolution.com)). The client will receive the edited photo/ photos by text within two weeks, the countdown starting the date after payment for the photo/ photos (photo/ photos assumes all uploaded photos were part of the same order submission on our website. 15 mb maximum upload) has been received in full by the photographer from the client. The extent to which the photo/ photos are edited/ altered is solely determined by the photographer.

The number that the client receives the photo/ photos (edited/ non-edited) on will be the same phone number they submitted on our website for the specific service in question, provided another phone number has not been provided for that specific service (Same for sales invoices).

**Payment:** The Clients will pay the hourly rate of \$89.99, following the completion of the session/ sessions. Once a session has started, the photographer will work the full hour. Should the client decide to end the session early (before the full hour is complete), the full amount of \$89.99 for the hour is still owed by the client to the photographer. The photo/ photos from the session/ sessions will not be sent by the photographer to the client until the client's payment for the session/ sessions has been received in full.

Payment for edited photo/ photos are received in full by the photographer from the client before the edited photo/ photos are received by the client from the photographer.

Methods of payment: cash or check (must be exchanged in person)/ debit or credit card, digital wallet (Google Pay, Apple Pay, and Samsung Pay), or AHC bank transfer (Invoice sent by text to the client via Square).

### **Terms and Conditions**

**Ownership:** All photos taken by/ edited by the photographer belong to the photographer. If the client wishes to use the photos taken by/ edited by the photographer on social media or other online platforms, they must explicitly state that the photos were taken/ edited (or both if applicable) by Rogue Valley Resolution in the social media post/ other online publication. Photos taken by the photographer for the client can be used for advertising purposes by the client, provided the client using the photos for advertising purposes explicitly states that the photos were taken/ edited (or both if applicable) by Rogue Valley Resolution.

**Liability:** The photographer will not be held liable for any damages or injuries that occur during or after the session.

**Refund Policy:** The client will not be issued any refunds after the photography session/ sessions have taken place and the photo/ photos from the session/ sessions have been received on time. If the photographer must cancel the session or leave the session early due to other obligations, the client will not be charged for the session. If the photographer fails to deliver the photo/ photos within one week, the countdown starting the date after payment for the session/ sessions has been received in full by the photographer from the client, the client will be issued a refund for the session/ sessions. The client will not be issued any refunds except if the photo/ photos are confirmed late (past the one-week period, the countdown starting the date after payment for the session/ sessions has been received in full by the photographer from the client). If the client cancels before the session has begun, no money will be owed to the photographer.

The client will be issued a refund for edited photo/ photos that have been paid for separately at the \$9.99 per image fee if the photographer fails to deliver the edited photo/ photos within two weeks, the countdown starting the date after payment for the edited photo/ photos has been received in full by the photographer from the client. Refunds will not be made after the edited photo/ photos have been received by the client from the photographer on time. Refunds will not be issued except when the edited photo/ photos are confirmed late (past the two-week period, the countdown starting the date after payment for the edited photo/ photos has been received in full by the photographer from the client).
